FCC recognizes that a child's first years are crucial to life success and has developed programs that provide learning and developmental support to young children and their families. We successfully support parents and caregivers with unique needs as they nurture and raise their children, by addressing the wide range of a child's and parent/caregivers social, emotional, and family functioning needs. 1,200 participants were served through a variety of Family Support programs including prenatal services, playgroups for toddlers and their parents/caregivers, health and wellness programming, case management and family advocacy, basic needs assistance, parenting classes, family support groups, educational workshops, and community building activities.

Our Education programs provide vital, high-quality early childhood education and supplemental programs for children in preschool and grades K-5. 295 children participated in our Education programming, including preschool readiness programs, licensed preschools, afterschool Homework Club, and Summer Academic Enrichment summer camp.

We work collaboratively with community members and partners to identify relevant needs and solutions, including the special health and wellness needs of pregnant mothers and parents/caregivers of infants and young children. FCC alleviates the stressors that frequently impair child development while providing opportunities for families to build strong homes in which to raise healthy children. 148 participants were served through a variety of Healthy Connections programs including disease prevention workshops and clinics, exercise classes, healthy eating, nutrition and cooking classes, and more.
